Purpose

The Rising Leaders program of the Florida Collectors Association identifies promising individuals in the accounts receivable management sector. These individuals are carefully chosen by the FCA Leadership Development Committee as potential future leaders within both the Association and the industry. The committee's primary aim is to nurture leadership qualities by fostering the growth and sustainability of emerging professionals in the field. This is achieved through offering valuable resources, providing mentoring opportunities, facilitating exposure, and creating networking avenues for those still developing within the industry.

The FCA Leadership Development Committee identifies a Rising Leader as an individual who embodies the following traits:

Commitment to Leadership: Actively seeks opportunities for personal and professional growth in leadership roles.

Strong Initiative: Demonstrates a willingness to tackle challenges with focus and discipline.

Openness to Feedback: Embraces constructive criticism and coaching to enhance personal development.

Collaborative Spirit: Engages eagerly in collective learning experiences and contributes to the growth of others in the program.

Leadership Goals: Maintains a clear vision of how their evolving leadership skills will be utilized in future endeavors.

Industry Dedication: Shows a strong commitment to improving their organization and contributing to the advancement of the industry as a whole.

Qualifications

A natural person of 18 years or older.

An individual FCA member or an employee of any FCA Company Member, including Affiliate, Attorney or Creditor Leadership role/position at your company or organization.

Approval from your manager or supervisor to participate in the Rising Leader Program to meet the Expectations of Program Members listed below.

Expectations of Program Members

Attend and participate in-person at the FCA Annual Conference.

Attend and participate in at least two (2) Rising Leaders quarterly virtual meetings.

Complete any assigned reading, exercises or other tasks.

Embrace the values of the Program through aligning your actions with the Leadership Development Committee's definition of a Rising Leader (defined above under "Purpose").

Attach a professional reference (e.g.: manager, supervisor, client, vendor, or other industry member).

1. Complete all sections indicating Not Applicable (N/A) when necessary.
2. Please limit your responses to the word count allotted for each section.
