COMMITTEE DESCRIPTIONS

Membership/Grievance Committee

The Membership and Grievance Committee is a committee that assists the Association in soliciting potential new members and vetting membership applicants' qualifications and provides advice and recommendations to the Board of Directors. The Committee is also tasked with the accepting any consumer, regulatory, or third party grievances against any member and advising the Board of Directors as to any penalties or actions in accordance with the Associations By-Laws.

Committee Member Qualifications

- An FCA member having a unique interest, perspective, and expertise which advances this Committee's Purpose, and allows the member to fulfill his or her Responsibilities.
- Committee members should possess the desire and time to dedicate to the Committee in assisting in soliciting high-quality members to the Association.
- Committee members should also possess an unbiased and objective view in gathering information against any Association member so that the Committee can conduct a fair analysis and consideration of any grievance.

Education/Conference Committee

The Education/Conference Committee is a committee of FCA's members that plans all aspects of an annual educational conference including site selection, programs, and speakers while maintaining the board-approved budget.

Committee Member Qualifications

- An FCA member having a unique interest, perspective, and expertise which advances this Committee's purpose and allows the member to fulfill his or her Responsibilities.
- Committee members should possess the desire and time to dedicate to the Committee in assisting in preparing a high-quality Annual Conference and Conference Speakers and Information for its Members. This Committee meets for one hour once per month.

Social Media Committee

The Social Media Committee is a committee of FCA's members that develops, designs, and publishes electronic materials to serve all aspects of FCA's external marketing needs, including communications and announcements to Members and the general public through its various social media platforms. The purpose of the Committee is to work in conjunction with all other FCA Standing Committees and any existing ad hoc Committees formed by the Board of Directors from time to time to educate, market, and communicate information to FCA's Members, industry-related affiliates, and the General Public.

- An FCA member having a unique interest, perspective, and expertise which advances this Committee's Purpose and allows the Member to fulfill his or her Responsibilities.
- Committee members should possess the desire and time to dedicate to the Committee in assisting in preparing high-quality social media marketing materials for its publications and announcements.

Legislative Committee

The Legislative Committee is a committee of FCA's Board of Directors that serves as the Association's Legislative, Regulatory, and Administration "Watchdog." The Committee's purpose is to take a proactive approach to prevent adverse regulations or laws that may impact the credit, billing, and collection industries.

- An FCA member having a unique interest, perspective, and expertise which advances this Committee's Purpose and allows the member to fulfill his or her Responsibilities.
- Committee members should possess the desire and time to dedicate to the Committee in assisting in preparing informative and detailed reports on Florida Legislative issues.
